- Conducts safety inspections to reduce or eliminate injuries or deaths associated to with working on and adjacent to railroad property; inspections include carrier facilities, rolling stock and equipment used by carriers.
- Performs duty officer responsibilities on a rotating basis for accidents/incidents that occur after normal work hours; receives preliminary incident information and conducts follow-up telephone calls to the reporting carrier and to federal and state agencies to initiate investigation procedures.
- Conducts safety training and investigations on federal and state regulations for carrier employees, shipping groups, labor unions and the general public.
- Performs other responsibilities as required or assigned.
