Arbitrators' ruling results in wage increases for BMWED Amtrak MOW employees

A final and binding arbitration decision which, most notably, increases the wage rates of Amtrak MOW employees was reached March 25 and amounts to an average raise of 3.1 percent per year. The wage increases are retroactive to Jan. 1, 2010, and back pay will be paid to all BMWED members, active or retired, who earned money during the period in question.

A three-person panel of neutrals rendered the decision, which was negotiated by the Passenger Rail Labor Bargaining Coalition (a collaboration of the BMWED and the Brotherhood of Railroad Signalmen) and is not subject to appeal or membership ratification. The agreement goes into effect immediately, and Amtrak agrees that there will be no delay in calculating and distributing the back paychecks.

Under the decision, the average back pay from April 1, 2014 to Jan. 1, 2010, after health and welfare cost sharing deductions are rendered, will be \$11,496 for straight time calculation. All earned overtime during the back pay period will be paid as well. As an example, if 20 percent of your gross earnings were in overtime hours, the aver-

age back pay calculation would be \$13,890.

The arbitration panel also found three administrative work rules previously agreed to by other crafts (direct deposit of paychecks, biweekly pay and defining the start of the work week with respect to payroll as Monday) to be a part of this newly negotiated agreement with Amtrak and the PRLBC.

Jed Dodd, BMWED General

Chairman (Pennsylvania Federation) and Chairman of the PRLBC, along with BRS General Chairman David Ingersoll, passed along many thanks to the members for their strength, discipline and solidarity through the difficult and frustrating Amtrak contract struggle. "Without your effort, and the resolve of all of our members who supported the Union and endured Amtrak's nonsense throughout this struggle

for a new contract, we would not have a new contract."

BMWED President Freddie Simpson offered, "Working with our brothers in the BRS within the PRLBC framework proved a success and illustrates what we can accomplish when we work together."

Health Benefits for Occupationally Disabled Members Increased Effective May 1, 2014

The Board of Trustees of the BMWE Health and Welfare Plan for Occupationally Disabled Members is pleased to announce a benefit increase for all covered members and their dependents to become effective May 1, 2014. On and after that date, the lifetime maximum benefit per covered person will increase from \$130,000 to \$141,400.

This coverage is provided to

occupationally disabled members and their dependents, as well as surviving spouses and children of members who suffer a fatal on-the-job injury, who satisfy the eligibility requirements of the Plan and who are members of a participating federation, division or other group on whose behalf contributions are made to the Plan. Participating federations include: the Allied

Federation (limited to those groups who participate in the Plan), the Southern System Division and the Consolidated Rail System Federation (limited to the former members of the Nickel Plate Wheeling & Lake Erie Federation).

Lawrence E. "Larry" Kowalski





BMWED member Thomas Tarantella seeks U.S. Congressional seat in Pennsylvania

When you watch Brother Tom Tarantella speak about politics, when you ask about his plans if he were sent to Washington, it becomes easy to see how a 54-year-old political novice, a former Army paratrooper turned railroader from Ronovo, Pa., decided to mount a campaign for Congress. It's the passion. Brother Tarantella has a lot of it.

"Some people might ask, why is this guy doing this?" Brother Tarantella asks rhetorically. "Well, I'll tell you why. It's for the people. The people like you and me. I'm serious. I really believe it."

He is serious. You can tell as soon as you meet him that the guy has spunk. He has charisma. And, most of all, he has big ambitions. Brother Tarantella, a machine operator for Norfolk Southern Railroad and a member of the Pennsylvania Federation Local Lodge 3030, wants to unseat incumbent Republican Congressman Glenn Thompson in Pennsylvania's 5th Congressional District. He concedes it won't be easy. That the deck is stacked against working-class people like him. That all the underdog clichés apply. It's just that this underdog is feisty.

"Thompson, he's taking out full-page ads in the paper, he's going on bus tours, because he's running scared," Brother Tarantella said. "I'm a threat. I can win this thing. I know I can."

The BMWED wants Brother Tarantella to win, too. He has our full endorsement in the race, both in the May 20 Democratic primary, where he faces a challenger in Brookville, Pa. lawyer Kerith Strano Taylor, and, if he progresses, in the November general election versus Thompson. When it comes to the working-class, labor-friendly issues with which BMWED railroaders are most concerned, we feel Brother Tarantella would be a strong advocate on Capitol Hill.

"Incumbent U.S. Rep. Glen Thompson has a history of voting against unionized labor issues at every turn as well as middle class workers' rights in general. He's been detrimental to his district and our country and needs to be replaced. Our very own BMWED Brother Tom Tarantella is the perfect candidate for the job. He has our Brotherhood's full support," BMWED Director of Government Affairs Charlie Hogue said.

When it comes to so-called "right-to-work," union-busting legislation, Brother Tarantella sees right through it. "Whatever secret, slick name they want to give it to fool the people, just know that I'm against it," he said. "I believe in supporting unions and the workers' right to bargain and organize for a united, stronger voice. It may not be what corporate America and it may not be what the 'one percenters' want to hear, but it's the right thing for the people."

Brother Tarantella, who was born and raised in the small town of Ronovo, has unfortunately witnessed what can happen to a community when its industry is shipped overseas. If elected, he is determined to slow, if not halt, the outsourcing of jobs.

"I am adamantly opposed to a giving a corporation a tax deduction for exporting jobs out of this country," he said. "Why should we reward companies who move operations to China? All because they're greedy. It's lunacy."

When Brother Tarantella speaks on these issues, he impulsively stands for added impact. He gets animated and excited, but it's an affable passion that's fun and draws your attention. It is captivating to engage him in conversation. It is something his BMWED representative, Vice Chairperson Charlie Hansler has noticed, too.

"You have to give Tommy credit for going for it; for standing up and taking on the responsibility. Not many people would do what he's doing," Brother Hansler said. "I think it's great. He has a belief in his country and he wants to help it succeed."

The most noteworthy aspect of Brother Tarantella's career, and the distinction that his opponents cannot match, is his 22-year distinguished service in the U.S. Army as a member of the Rapid Deployment Force. As a paratrooper, Brother Tarantella was awarded several Campaign Ribbons, a Bronze Star, five Meritorious Service Medals, four Army Commendation Medals, 13 Army Achievement Medals and saw deployments across the globe. He was honorably discharged in 2002.

"I will fight for better pay for our military and their families," Brother Tarantella said. "I will fight for our wounded warriors, mentally ill, and the well-being of our military families and

veterans. I will work to give our veterans the health care, benefits, education, and the job opportunities they deserve."

BMWED President Freddie Simpson also offered support. "If I could vote in the Pennsylvania 5th District, I would proudly pull the lever for Brother Tom Tarantella," he said. "Brother Tom is a strong union man who understands what needs to get done in Washington in order for the middle class to succeed. All BMWED railroaders would benefit from his representation. Those members voting in his district should cast their ballot for Brother Tarantella in the May 20 primary and again in November, both for the good of our union and the well-being of this great country."

2014 PROPOSAL NO. 1 DIRECT ELECTION OF NATIONAL DIVISION OFFICERS SUBMITTED BY PENNSYLVANIA FEDERATION JOINT PROTECTIVE BOARD

ARTICLE I, ADD SECTION 3(a), TO READ:

Sec. 3(a). Notwithstanding any provision of these Bylaws to the contrary, effective with the 2018 elections and all general elections thereafter, all National Division Officers will be elected by rank and file mail ballot referendum. Nominations for office will be received at the 2018 National Division Convention. Elections will be conducted in November 2018 with the successful candidates taking office on December 1, 2018. Subsequent general elections will be governed accordingly. Elections will be supervised and the ballots counted by the American Arbitration Association.

The National Division Officers shall make reasonable rules for the nominating process at the National Division Convention and publicize these rules in January of the Convention year. The National Division Officers shall make reasonable rules for the mailing of the ballots in November of the election year except that there must be 25 days between the date the ballots are mailed and the ballots are counted.

Candidates receiving the most votes will be declared the winner.

There will be printed in September and October of the BMWED Journal and mailed before the ballots are mailed statements from the candidates. The National Division Officers shall make reasonable rules for the candidates to have their material printed in the Journal. This will include, but not be limited to, deadlines for submission of candidate's statement, format for the submission of candidate's statement and may include the requirement to obtain a certain number of signatures from members in good standing on forms provided by the National Division supporting the candidate's desire to print their information in the Journal.

Vacancies between elections will be filled in accordance with the other provisions of these Bylaws.

2014 PROPOSAL NO. 2 SUBMITTED BY NATIONAL DIVISION

ARTICLE I, SECTION 3, PARAGRAPH 1 BE AMENDED TO READ:

Sec. 3. The Officers of the National Division shall consist of a President, five (5) Vice Presidents, a Secretary-Treasurer, and five (5) six (6) members of the Executive Board. The National Division President may appoint a Chaplain, Messenger, Sentinels and Sergeants-at-Arms at each Convention of the National Division.

2014 PROPOSAL NO. 3 SUBMITTED BY NATIONAL DIVISION

ARTICLE I, SECTION 4, PARAGRAPH 1 BE AMENDED TO READ:

Sec. 4. The National Division Officers shall be members of a BMWED lodge and shall be nominated and elected at the regular quadrennial Conventions of the National Division by a representative majority vote of the duly accredited delegates elected by secret ballot. In the event balloting results in no candidate winning a majority vote (a number greater than half of the total possible votes), the candidate garnering the fewest votes shall be dropped from the ballot, and a run-off ballot will be conducted. If there is only one nominee for an office, there shall be no ballot for that position, and the nominee will be declared elected. The four Four (4) Vice Presidents and the five (5) four (4) members of the Executive Board shall be from a System Division or Federation in his respective region and shall be nominated by delegates from his respective region. One (1) Vice-President and two (2) members of the Executive Board shall be from any System Division or Federation and may be nominated by any delegate, regardless of region. Those officers so nominated at election may be referred to as "at-large." National Division Officers shall serve for a term of four (4) years unless removed by death, resignation or for cause, and shall be eligible for re-election. They shall be installed during the session of the National Division Convention in which they are elected, their installation and term of office to be effective commencing September 1 following election except in the case of filling an unexpired term, when such Officer shall take charge of his office immediately upon being elected and he shall serve for the remainder of the term; provided, however, that the term of office of any temporary National Division Officer will expire immediately upon the election and installation of his successor. Any vacancy in such office, temporary or permanent in nature, shall be filled in accordance with the terms of these Bylaws. Bylaws, Continued on Page 23

Brother Russell W. Mobry passed away Monday, March 3, 2014 in Mankato, Minn. He was 93.

Brother Mobry was a General Chairman off the former Chicago, Milwaukee, St. Paul & Pacific System Federation (now the Burlington System Division) until his retirement in June 1980. He began his railroad career several years prior, working in the track department on the old Milwaukee Railroad.

Born on May 30, 1920 in Palo Alto County, Iowa, Brother Mobry entered the U.S. Army on March 5, 1942, serving with the Eastern Defense Command in the South Pacific during World War II. On Aug. 23, 1943, Brother Mobry married his wife, Betty O'Connor Mobry, and last year the couple celebrated their 70th wedding anniversary. Together they had eight children, 16 grandchildren and 14 great-grandchildren.

Brother Mobry retired from the Brotherhood on June 1, 1980. He stayed busy upon retirement by participating with the Lee C. Prentice American Legion Post 36, the Martin County (Minn.) VFW Post 1222 and St. John Vianney Catholic Church.

"Brother Russ was a superb officer in our Brotherhood, a strong supporter of railroaders and their labor rights, an American soldier and hero, and an all-around terrific man," President Freddie Simpson said. "I want to send our deepest and most sincere condolences to his wife, Betty, and his family. We are very saddened by the loss of Brother Russ, who was an exceptional member of our union and a true gentleman."

BMWED Legislative Issues— 113th Congress

The United States gubernatorial elections of 2014 will be held on Nov. 4, 2014 in 36 states and three territories concurrent with other elections during the United States General election of 2014.

Retiring and term-limited Republican incumbents (3)

Jan Brewer (Arizona)

Governor Jan Brewer will be termlimited in 2014 despite only serving one full term, as Arizona state law limits office holders to two consecutive terms, regardless of whether they

are full or partial terms. In November 2012, Brewer declared she was looking into what she called "ambiguity" in Arizona's term-limit law to seek a second full four-year term.

Arizona Secretary of State Ken Bennett, Mesa Mayor Scott Smith, State Treasurer of Arizona Doug Ducey, State Senator Al Melvin, former Go Daddy Executive Vice President Christine Jones, and former County attorney of Maricopa County Andrew Thomas are running for the Republican nomination.

Fred DuVal, former Chairman of the Arizona Board of Regents, is running for the Democratic nomination.

Dave Heineman (Nebraska)

Governor Dave Heineman will be term-limited in 2014.

State Senators Tom Carlson, Charlie Janssen and Beau McCoy are running for the Republican nomination. Other potential Republican candidates include Auditor of Public Accounts Mike Foley and businessman Pete Ricketts.

Executive Director of the Center for Rural Affairs Chuck Hassebrook is running for the Democratic nomination. State Senator Annette Dubas was also running, but she has withdrawn, leaving Hassebrook the only Democratic candidate.

Rick Perry (Texas)

Governor Rick Perry is eligible to run for re-election, but announced on July 8 that he is not running for a fourth term. Perry was re-elected to a third term with 55.1% of the vote in 2010.

Attorney General Greg Abbott, perennial candidate Larry Kilgore and former Univision personality Miriam Martinez are running for the Republican nomination

State Senator Wendy Davis is running for the Democratic nomination. Kathie Glass, the Libertarian nominee for Governor in 2010, is running for the Libertarian nomination.

Retiring and term-limited Democratic incumbents (5)

Mike Beebe (Arkansas)

Governor Mike Beebe will be term-limited in 2014.

Former Congressman Mike Ross is running for the Democratic nomination.

Republican candidates include former Congressman Asa Hutchinson, State Representative Debra Hobbs, and food safety company founder Curtis Coleman.

Martin O'Malley (Maryland)

Governor Martin O'Malley will be term-limited in 2014.

O'Malley has endorsed Lieutenant Governor Anthony Brown to succeed him. Also running for the Democratic nomination are Attorney General Douglas Gansler and State Delegate Heather Mizeur, and potentially Representative Dutch Ruppersberger.

On the Republican side, declared candidates include Harford County Executive David R. Craig, Chairman of Change Maryland and former Maryland Secretary of Appointments Larry Hogan, Delegate Ron George, former Charles County Republican Central Committee Chairman Charles Lollar, and 2012 U.S. Senate candidate Brian Vaeth.

Deval Patrick (Massachusetts)

Governor Deval Patrick is eligible to run for re-election, but has decided not to seek a third term.

Declared Democratic candidates include PAREXEL executive Joseph Avellone, former Administrator of the Centers for Medicare and Medicaid Services Donald Berwick, Attorney General Martha Coakley, Treasurer Steve Grossman, and former Assistant Secretary for Intergovernmental Affairs Juliette Kayyem.

Declared Republican candidates include former Massachusetts cabinet official and 2010 nominee Charlie Baker, and TEA Party member and Shrewsbury small businessman Mark Fisher.

Lincoln Chafee (Rhode Island)

Governor Lincoln Chafee is retiring after one term in office. Chafee was elected with 36.1% in a competitive three-way race in 2010 in which he ran as an independent. He became a Democrat in May 2013, promoting speculation he would run for a second term, but later announced that he would not run for re-election on Sept. 4, 2013.

Providence Mayor Angel Taveras is running for the Democratic nomination. State Treasurer Gina Raimondo and former United States Department of Education official Clay Pell are also expected to run.

Cranston Mayor Allan Fung is running for the Republican nomination. Moderate Party Chairman Ken Block, who received 6.5% of the vote in the 2010 gubernatorial election, had filed to run again for the Moderate Party. He has since switched to run as a Republican.

John de Jongh (United States Virgin Islands)

Governor John de Jongh will be term-limited in 2014.

Republican incumbents running for re-election (18)

Robert Bentley (Alabama)

Governor Robert Bentley is running for re-election. Bentley was elected with 57.9 percent of the vote in 2010.

Former Morgan County Commissioner Stacy Lee George is running in the Republican primary, as is Bob Starkey, a retired software company executive.

Former Major League Baseball player and businessman Kevin Bass and former U.S. Representative Parker Griffith are running for the Democratic nomination.

Sean Parnell (Alaska)

Governor Sean Parnell is running for another term. Attorney and 2010 Republican primary candidate Bill Walker was running again in the Republican primary, but he has withdrawn and is now running as an Independent.

Former Mayor of Juneau Byron Mallott is running for the Democratic nomination. Other potential Democratic candidates include 2010 nominee Ethan Berkowitz and State Senator Bill Wielechowski.

Rick Scott (Florida)

Governor Rick Scott was elected with 48.9 percent of the vote in 2010, defeating then-Chief Financial Officer of Florida Alex Sink by a margin of just over 1 percent. He has announced he will seek a second term.

Challengers include Democratic State Senator Nan Rich, former Republican Governor turned Democrat Charlie Crist and Economist and 2010 Independent nominee for Governor Farid Khavari. Other potential Democratic nominees include City Manager of Miami Beach Jimmy Morales, and Fort Lauderdale Mayor Jack Seiler.

2010 Democratic nominee and former Chief Financial Officer of Florida Alex Sink and U.S. Senator Bill Nelson have decided not to seek the Democratic nomination.

Former Libertarian Party of Florida Chairman Adrian Wyllie is running for his party's nomination.

Nathan Deal (Georgia)

Governor Nathan Deal has announced his plans to run for re-election. Deal was elected with 53 percent of the vote in 2010.

BMWED Training Helps First Responders Locate Emergencies

The BMWED is training local fire departments and EMTs to easily locate emergencies near railroads in hopes of accelerating response times.

The idea for first responder training sparked when AT&SFF General Chairman Gary Marquart and Vice General Chairman and Secretary-Treasurer Corey Wilbanks learned about an incident that led to a railroad contractor being severely injured on the job, partially due to the time it took first responders to locate the accident.

"If the first responders had known mile posts, they could have gotten to him faster," Wilbanks said.

In February 2014, AT&SFF partnered with BNSF Railway to roll out the training. "It's a joint venture between us and the railroad to train these people to find these locations if they need them," Marquart said.

Wilbanks conducts the training sessions with the fire departments and EMTs along his section of territory. He and Marquart say they would like the trainings to spread across the entire system. Chris Wilbanks, assistant fire chief for Howell County Rural Fire Department in West Plains, Mo., agrees.

"We have a lot of rail gangs that come through this area. They seem to maintain this track a lot. There are several bands that are quite wide between roads," Chris Wilbanks said. "This training is going to be very helpful for us. We need to get it out to 9-1-1 and the other groups too. It would be a great thing if we could expand on

Sometimes when calling in an emergency, railroad workers only have mile posts to tell them where they are. "They're from Washington," Chris Wilbanks said. "They're not going to know Missouri."

One solution for this is to teach first responders how to read track charts, maps that show road crossings and mile posts. At the training sessions he conducts, Corey Wilbanks gives track charts to first responders and trains them on how to read them.

According to Chris Wilbanks, both fire departments and maintenance of way employees benefit from the training sessions. "Knowing mile markers means we can get there faster, and we'll have better access to fires along rails," he said.

"If there is an emergency along the right of way somewhere, the employees can give them a location, and they have track charts, and they know the quickest access points along the right of way," Marquart said.

Even though first responders are busy, trainees so far have been very receptive to the training sessions, according to Corey Wilbanks. "They're not thinking that it's a waste of their time by any means. Every one of them seems to take it in to be a useful tool," he

In fact, the training has already proven to be useful. Less than a week after a fire department training session, a train called in a grass fire between Koshkonong and Thayer, Mo. "It wasn't near a crossing or anything like that," Corey Wilbanks said. "The train called it in, and the first responders called the train back and said, 'These guys have track charts and know how to read them. Can you give us a mile post for that fire?' So the train gave them a mile post for the fire, and they got right to it."

The first responders were able to locate the fire quickly. "Rather

than going out and searching from Koshkonong to Thayer, which is about 20 miles, and searching that whole area, they were able to pinpoint where exactly it was," Corey Wilbanks said.

Marquart said, "They were able to use that training to find the correct location before it got out of hand."

The importance of educating first responders is clear to Marquart. "We work in a very dangerous industry where employees unfortunately do, from time to time, suffer severe if not fatal injuries. We need to get them immediate medical assistance if we can, and this is an excellent way to provide that to the employees," Marquart said.

If anything could save somebody's life or get a first responder there quicker to give them treatment, it's definitely beneficial," Corey Wilbanks said.




VGC Wilbanks (top and bottom) explains the intricacies of reading track charts and understanding mile post locations to emergency responders.



A Vice President Speaks

Silica dust exposure from ballast operations presents a real danger

Recently, I was told a story about a member who had spent two and a half weeks walking along the ballast line, manually dumping a rock train on main line track. It was not an easy assignment. As

often happens, the remote control for the rock cars was malfunctioning, so the two BMWED track workers were forced to push a button on the side of each car to open the doors and dump the rock. Perhaps this is sounding familiar?

Walking between five to seven miles daily alongside a train, the two members dutifully unloaded the fresh granite ballast amidst a never-ending cloud of dust. By the end of each day, both men reported their clothes, hair, nostrils and taste buds covered in the chalky, grayish powder. One member said during every shower, he had to wash his hair twice in order to fully remove the grime. They both reported nightly headaches. In a profession that has its fair share of tough days, this particular project became one of the more loathsome of their careers.

About a week into the rock dumping process, one of the members asked the roadmaster for

a dust mask. Deep in a corner of the supply closet, the boss provided one made of paper, which may provide little or no protection against high concentrations of silica. It didn't take long to discover that, along with making radio communication virtually impossible, it also hardly kept the dust at bay.

All told, these two members are lucky, because the rock train eventually left and the dust finally settled. The two men went back to their basic section work. However, many of our members are not as fortunate. They work on surfacing teams where silica dust from the handling of ballast rock is an everyday occurrence. And that is dangerous.

Increasingly, research into the effects of sustained silica dust inhalation is revealing terrible news. What we are learning is that workers who are exposed to silica dust face twice the normal risk of lung cancer and often develop other lung-related diseases such as asthma. Even more worrisome, data suggests that smokers who also breathe in silica dust for 30 years (the average length of a career) have 42 times the risk of lung cancer compared to even light smokers who aren't exposed to silica

Safety standards meant to reduce exposure to deadly silica dust, enforced by the Occupational Safety and Health Administration, have not been updated since the early 1970s. Unfortunately, these existing OSHA standards are too weak to satisfactorily protect BMWED members, especially those who dump ballast or work on surfacing teams. The BMWED successfully pushed the Federal Railroad Administration to require mandatory "engineering controls" (heating, air conditioning and positive pressurized ventilation systems) in certain post-2003 dustgenerating machines to protect the operators in enclosed cabs (see 49 CFR, 214.505). We are now engaged in rulemaking with OSHA to lower the legal exposure limit for all MOW workers, and those new lower limits, when adopted, will apply to workers both inside and outside of enclosed cabs along the railroad right-of-way.

BMWED Director of Safety Rick Inclima, along with BMWED officers and other IBT Safety and Health Department officials, have led efforts to push OSHA into lowering the permissible exposure limits of silica dust to all MOW employees. We have also asked that OSHA work collectively with the FRA on the application and effectiveness of engineering controls and work practices within the railroad industry to control rail workers' exposure to airborne silica.

OSHA recently concluded a three-week long public hearing in Washington, D.C. on proposed rules to limit workers' exposure to silica dust. Several experts were brought in to provide opinions, and most concluded that the current exposure limits are woefully weak. George Washington University

School of Public Health Lecturer Celeste Monforton summed it up rather succinctly. "It's really a national disgrace that we allow exposures to silica dust that are so high," she said during OSHA testimony.

OSHA's proposed rule would cut in half the amount of silica allowed in the air from 100 micrograms per square meter to 50 micrograms. Keeping dust-forming rock damp with a steady stream of water, along with the improved use of respirators would help mitigate worker exposure, OSHA said in its report.

For BMWED workers exposed to silica dust, it is important to remember to take the appropriate precautions and to demand that your railroad carrier provide you with the proper relief. If you feel your requests are being ignored, contact your local BMWED representative. Silica dust exposure, specifically of a prolonged time period, is extremely detrimental to your health and is something this union is working to rectify for its members. Your health is important and we will stand together to ensure that it is a priority that is not ignored by the railroads.

On a personal note, this will be my last post to "A Vice President Speaks," for it is my intention to retire at the end of this term, Sept. 1, 2014. I would like to take this opportunity to say thank you for allowing me to work for you over the years. I wish each and every one of you good health and happiness into the future. God bless. It has been an honor and a privilege to have worked with all of you.

Income Disparity Hurts Working Families


and Wyoming – all of the income gains between 1979 and 2007 went to those in the top one percent, while the rest saw incomes drop.

Still, there is more to be done. Lawmakers can't continue to turn their back on hard-working Americans while embracing the most fortunate. It's not good policy, and it's not the principles on which this country was built.

State School Superintendent John Barge and Mayor of Dalton David Pennington are running for the Republican nomination.

State Senator Jason Carter, the grandson of former President and Governor Jimmy Carter, is running for the Democratic nomination. Connie Stokes, a former Georgia State Senator and DeKalb County Commissioner, was running for governor, but is now running for lieutenant governor.

Butch Otter (Idaho)

Governor Butch Otter has announced he will seek a third term. Otter was elected to a second term with 59.1 percent of the vote in 2010. State Senator Russ Fulcher is challenging Otter for the Republican nomination.

A.J. Balukoff, President of the Boise School Board, is running for the Democratic nomination.

Terry Branstad (lowa)

Governor Terry Branstad has announced that he will seek a sixth non-consecutive term. He was elected to a fifth term (non-consecutive) with 53 percent of the vote in 2010. Political activist Tom Hoefling has announced a primary challenge to Branstad.

Assistant Majority Leader of the Iowa State Senate Jack Hatch, former Des Moines school board member Jonathan Narcisse and Webster bus driver Paul Dahl are all running for the Democratic nomination.

Sam Brownback (Kansas)

Governor Sam Brownback has announced he will run for re-election. Brownback was elected with 63.4 percent of the vote in 2010.

Paul Davis, Minority Leader of the Kansas House of Representatives, is running for the Democratic nomination. According to The Fix, Democrats see this as the "sleeper race" of 2014.

Paul LePage (Maine)

Governor Paul LePage has announced he will run for a second term. LePage was elected with 38.3 percent of the vote in a competitive three member race in 2010.

Congressman Mike Michaud is running for the Democratic nomination. Independent candidate Eliot Cutler, who finished second in Maine's 2010 gubernatorial election, is running again against LePage, former member of the Maine House of Representatives. David Slagger is running as a Green Independent.

Rick Snyder (Michigan)

Governor Rick Snyder is running for re-election to a second term. Snyder was elected with 58.1 percent of the vote in 2010.

Private Investigator Mark McFarlin is running for the Republican nomination.

Former Congressman Mark Schauer is running for the Democratic nomination.

Brian Sandoval (Nevada)

Governor Brian Sandoval has announced he will seek a second term. Sandoval was elected with 53.4 percent of the vote in 2010.

Businessman Edward "Eddie" Hamilton is running for the Republican nomination.

Anthropology Professor Frederick "Fred" Conquest and Businessman Chris Hyepock are running for the Democratic nomination.

Family Therapist David Lory VanDerBeek is running for the Independent American nomination.

Susana Martinez (New Mexico)

Governor Susana Martinez has announced that she will seek a second term. Martinez was elected with 53.6 percent of the vote in 2010.

State Attorney General Gary King, Businessman Alan Webber, former New Mexico Director of the Farm Service Agency Lawrence Rael, and State Senator's Howie Morales and Linda Lopez are declared Democrats currently in the race.

John Kasich (Ohio)

Governor John Kasich has announced he will seek a second term. Kasich was elected with 49.4 percent of the vote in 2010.

Cuyahoga County Executive Ed FitzGerald and Hamilton County Commissioner Todd Portune are running for the Democratic nomination.

Former Ohio state representative Charlie Earl is running for the Libertarian nomination.

Mary Fallin (Oklahoma)

Governor Mary Fallin has announced she will seek a second term. Fallin was elected with 60.1 percent of the vote in 2010.

2010 Republican Party Gubernatorial candidate Randy Brogdon is running again.

State Representative Joe Dorman is the only Democratic candidate currently running.

Tom Corbett (Pennsylvania)

Governor Tom Corbett has announced he will run for re-election to a second term. Corbett was elected with 54.5 percent of the vote in 2010.

Congresswoman Allyson Schwartz is running for the Democratic nomination. Other Democratic candidates include former Pennsylvania Secretary of Environmental Protection John Hanger, Lebanon County Commissioner Jo Ellen Litz, State Treasurer Rob McCord, former Pennsylvania Secretary of Environmental Protection Kathleen McGinty, businessman Max Myers, and businessman Tom Wolf.

Nikki Haley (South Carolina)

Governor Nikki Haley has announced that she will run for re-election. Haley was elected with 51.4 percent of the vote in 2010.

Democratic 2010 gubernatorial nominee, State Senator Vincent Sheheen, is seeking a rematch.

Bill Haslam (Tennessee)

Governor Bill Haslam has announced that he will run for re-election. Haslam was elected with 65 percent of the vote in 2010.

Sara Kyle, former Director of the Tennessee Regulatory Authority, is considering running for the Democratic nomination.

Scott Walker (Wisconsin)

Governor Scott Walker has announced that he will run for re-election. Walker was elected with 52.3 percent of the vote in 2010 and was subject to an unsuccessful recall election in 2012, which he won with 53.1 percent of the vote.

Former Wisconsin Secretary of Commerce Mary Burke is running for the Democratic nomination.

Matt Mead (Wyoming)

Governor Matt Mead has announced that he will run for re-election. Mead was elected with 71.6 percent of the vote in 2010. State Superintendent of Public Instruction Cindy Hill is running for the Republican nomination.

Republican incumbents eligible for re-election (2)

Eddie Calvo (Guam)

Governor Eddie Calvo will be eligible to run for re-election, but has so far not announced if he will do so. Calvo was elected with 50.6 percent of the vote in 2010.

Dennis Daugaard (South Dakota)

Governor Dennis Daugaard has not yet announced that he will run for re-election, but is expected to do so after the spring legislative session. Daugaard was elected with 61.5 percent of the vote in 2010. Republican former State Representative Lora Hubbel has announced a primary challenge to Daugaard.

Joe Lowe, the former Director of Wildland Fire Suppression, is running for the Democratic nomination. Other speculated candidates included former Commissioner of Schools and Public Lands Bryce Healy, former Congresswoman Stephanie Herseth Sandlin, and Sioux Falls Mayor Mike Huether, but they have all ruled out running for governor.

Democratic incumbents running for re-election (7)

Jerry Brown (California)

Governor Jerry Brown is running for re-election. He was elected to a third non-consecutive term with 53.1 percent of the vote in 2010, having previously served as Governor from 1975 to 1983.

State Assemblyman Tim Donnelly and former U.S. Treasury Department Official Neel Kashkari are running for the Republican nomination. Former Lieutenant Governor Abel Maldonado launched a campaign but then withdrew.

Much has been written about the outcome of the vote, with analysis ranging from optimism (the margin of the vote — 53-47 — was narrow, unions still have hope) to the dire (labor unions are dead and buried, their usefulness a thing of the past).

As is often the case in this era of 24-hour cable news and instantaneous internet punditry, a story can be spun a thousand different ways to fit a desired context. As Paul Simon famously sang, a man hears what he wants to hear and disregards the rest. But, with prejudices noted, there still remain some resounding truths to what led to the outcome at the Chattanooga VW plant. Frankly, if only one lesson is gleaned from the result of this vote, I sincerely hope it is this:

Money in politics is accelerating the extinction of the American middle class. We must put an end to the revolving door between public office and private gain.

If you don't understand the urgency of that statement, you're either filthy rich (statistically unlikely) or you're simply not paying close enough attention.

Some of you have probably heard me say that if you can find a Republican who is fair to the working man or woman, that I'd gladly take my picture with him or her. It's a line I use from time-to-time in speeches I give at union meetings across the country. Well, so far, the camera's still on the counter, collecting dust. That's because, discouragingly, the GOP has completely morphed into the corporate interest party. They govern solely for the wealthy.

At the Conservative Political Action Conference in March, a keystone of the GOP's long-term

The UAW/Volkswagen vote in Tennessee proves Big Money is out to get us

Arguably the biggest labor story of the year, at least at the time of this writing, is the United Auto Workers and its valiant yet failed attempt to organize a Volkswagen plant in Chattanooga, Tenn.

strategy focused on the eradication of labor unions. Truth be told, consolidating all the money and power to the top is actually all Republicans truly care about. Not guns. Not abortion. Not gay marriage. Those issues are simply ways to poach votes from the working class. The GOP's true ambition is to serve the wealthy by keeping open corporate tax loopholes and stacking the deck against the 95 percent of Americans who work for a living. That's why labor unions like us are so darn pesky, seeing as we provide counterbalance to their monetary scale.

Prominent Republican henchman Grover Norquist moderated a panel devoted to union busting and lowering corporation's labor costs by slashing wages and minimizing the workers' rights to bargain. The Huffington Post covered the meeting in a story titled "They're not dead yet." The "they're" in that headline is referring to us.

Norquist, a modern-day
Ebenezer Scrooge, largely funded
the anti-union billboards that
plastered Chattanooga highways
with fear-mongering and scare
tactics leading up to the UAW vote.
Previously focused on changing the
tax code to benefit the most
wealthy, Norquist has now added
union-busting to his résumé by
starting the Center for Worker
Freedom, which is mistakenly
named, because it actually accomplishes the opposite.

Through his union-busting enterprise, Norquist's fear mongering and scare tactics worked. His appeals to machismo, a sort of "real men don't need a union, they

can handle things all by themselves" false bravado, eventually cracked the foundation of the unionizing efforts. Norquist's finances spread lies in Chattanooga about unionization, but his cohorts in deceit, U.S. Sen. Bob Corker and Tennessee Gov. Bill Haslam, sure weren't going to sit the game out.

According to Nashville's News Channel 5, the Haslam administration held \$300 million in economic incentives at ransom in order to have a say in the outcome of the VW/UAW election. The "say" they wanted was a guarantee that the unionization vote would fail. The \$300 million would allow the VW plant to expand and create over 1,000 new jobs, but documents uncovered by Channel 5 state "the incentives ... are subject to works council (UAW) discussions between the State of Tennessee and VW being concluded to the satisfaction of the State of Tennessee."

According to the Chattanooga
Times Free Press, "three days
before the union election began,
State Sen. Bo Watson and House
Majority Leader Gerald McCormick
said the Republican-controlled
Legislature would be less willing to
support tax breaks and other
incentives for VW to expand and
add a new sports utility vehicle line
if workers voted to be represented
by the UAW. Corker also said
Volkswagen would soon announce
plans to expand the plant if workers
turned down the UAW."

If the blatant interference from Republicans on the behalf of corporate tycoons in the Chattanooga UAW vote is not severe enough to get your attention, or if you say to yourself, "I don't live in Tennessee. This won't affect me," well, I'm afraid you're wrong.

Two recent 5-4 decisions from the United States Supreme Court (McCutcheon v. FEC and Citizens United v. FEC) have made it easier for the richest Americans to influence elections through their extreme wealth, effectively buying the government and creating oligarchy. The five justices who voted in favor of Big Money were all appointed by Republican presidents. Suffice to say, this newly untapped stream of campaign finance is not going toward electing legislators who will look out for the average, American middle-class worker and voter. If a union-busting CEO is funding millions of dollars into a politician's campaign war chest, guess whose back is getting scratched if that politician gets elected? Hint — it's not yours.

We are all BMWED members working on the railroad tracks and bridges throughout the country, proud of our solidarity and what it affords us with - job security, a fair and living wage, overtime pay, good benefits, safe workplace practices. These are things that Volkswagen plant employees are seeking, as well. I stand with these workers and hope they are able to negotiate contracts despite the uneven playing field of Tennessee politics. I would proudly stand for a photograph with the brave plant workers that voted unsuccessfully to join the UAW and I wish them great success. As for a photo with Gov. Haslam or Sen. Corker, I doubt I could write a check big enough to get their attention.

John Hickenlooper (Colorado)

Governor John Hickenlooper is running for re-election. Hickenlooper was elected with 50.7 percent of the vote in 2010.

State Senator Greg Brophy and Former Congressman Tom Tancredo are running for the Republican nomination. Colorado Secretary of State Scott Gessler is a potential Republican candidate.

Neil Abercrombie (Hawaii)

Governor Neil Abercrombie launched his re-election campaign on April 29, 2013. Abercrombie was elected with 58.2 percent of the vote in 2010 over former Lieutenant Governor Duke Aiona. State Senator David Ige is challenging Abercrombie for the Democratic nomination.

Aiona might seek a rematch. Another potential Republican candidate is former Congressman Charles Djou.

Pat Quinn (Illinois)

Democratic Governor Pat Quinn is running for re-election. Quinn was elected to a full term with 46.6 percent of the vote in 2010.

Businessman Bruce Rauner, Treasurer Dan Rutherford, and State Senators Kirk Dillard and Bill Brady are running for the Republican nomination

Mark Dayton (Minnesota)

Governor Mark Dayton is running for re-election. Dayton was elected with 43.7 percent of the vote in 2010.

Teacher Rob Farnsworth, investment banker Scott Honour, Hennepin County Commissioner and former State Representative Jeff Johnson, perennial candidate Ole Savior, former Minority Leader of the Minnesota House of Representatives and candidate for Governor in 2010 Marty Seifert, State Senator and former radio host Dave Thompson, and State Representative and former Speaker of the Minnesota House of Representatives Kurt Zellers are seeking the Republican nomination. Activist Leslie Davis is seeking the DFL nomination.

John Kitzhaber (Oregon)

Governor John Kitzhaber is running for re-election. Kitzhaber was elected with 49.2 percent of the vote in 2010.

Peter Shumlin (Vermont)

Governor Peter Shumlin, re-elected in 2012, is running for re-election. (Vermont governors serve two-year terms.)

Democratic incumbents eligible for re-election (3)

Dan Malloy (Connecticut)

Governor Dan Malloy will be eligible to run for re-election, but has so far not announced if he will do so. Malloy was elected with 49.6 percent of the vote in 2010.

Former U.S. ambassador to Ireland and 2010 Republican gubernatorial candidate Tom Foley is challenging Malloy again after losing by less than 1 percent of the vote in 2010.

Maggie Hassan (New Hampshire)

Governor Maggie Hassan, elected in 2012, will be eligible to run for reelection. (New Hampshire's governors serve two-year terms.)

Former U.S. Representative Frank Guinta has not ruled out the possibility of running for the Republican nomination.

Andrew Cuomo (New York)


Governor Andrew Cuomo will be eligible to run for re-election. He has not officially announced that he will seek a second term, but has renamed his campaign committee Andrew Cuomo 2014 and has given other hints about his intentions. Cuomo was elected with 62.6 percent of the vote in 2010 over Carl Paladino.

Paladino might seek a rematch. Other potential Republican candidates are Westchester County Executive Rob Astorino, businessman Donald Trump, State Assemblyman Steven McLaughlin, Dutchess County Executive Marcus Molinaro and Harry Wilson, the nominee for State Comptroller in 2010.

Independent and Third Party incumbents eligible for re-election (1)

Eloy Inos (Northern Mariana Islands)

Governor Eloy Inos, who was elected as Lieutenant Governor in 2009 as a member of the Covenant Party, succeeded his predecessor Benigno Fitial (R) upon the latter's resignation on February 20, 2013 and will be eligible to run for a full term.



SECRETARY-TREASURER'S REPORT

Preparations for the Third Regular BMWED Convention, which will be held June 23-25, 2014, are in full swing. Local Lodge members are electing convention delegates and alternates to represent their Lodge and the

interests of its members and the Brotherhood. The National Division President has appointed the necessary committees to review submitted bylaw proposals and resolutions, and the entire BMWED is preparing to chart the course of our great union into the future.

Conventions provide the rank-and-file membership a direct say in how the organization will be governed through our Bylaws, who will lead this Brotherhood through the election of National Division Officers, and what resolutions will be adopted to establish our goals and objectives into the future. Individuals who have not previously submitted documents required when filing a railroad retirement annuity application, such as proofs of age, marriage, or military service, are encouraged to bring this material to the seminar.

The program will begin this year on a pilot basis, with seminars planned for Omaha on May 16, and Huntington on June 20. Additional details regarding registration and locations will be announced soon.

RRB field personnel will lead the Pre-Retirement Seminars, which will be held from 1:30 p.m. to 3:30 p.m. On those same dates and in those same locations, Informational Conferences sponsored by the Office of the Labor Member will be conducted from 8:30 a.m. to 12:15 p.m. for invited rail labor representatives.

2014 PROPOSAL NO. 4 SUBMITTED BY NATIONAL DIVISION

ARTICLE I, SECTION 7(b), PARAGRAPH 3 BE AMENDED TO READ:

Excluding those positions elected from nominations made at-large, in In the event of a vacancy in the office of Vice President or Executive Board member, those eligible to be elected to fill such vacancy, must be from a System Division or Federation of the region where the vacancy occurs, and must be nominated by a System Division or Federation Officer from that region.

2014 PROPOSAL NO. 5 SUBMITTED BY NATIONAL DIVISION

ARTICLE III, SECTION 5 BE AMENDED TO READ:

Sec. 5. He shall have the authority, subject to the approval of the National Division Executive Board, to appoint Assistants to the President to assist him in the discharge of the duties of his office per the requirements in Section 4 of this Article.

He may also delegate authority to act for him to any National Division Officer.

He may also deputize any member to be his immediate representative for particular duties. Such deputies are to possess only such power as is expressly delegated. Such deputies shall submit in writing a full and complete report of his actions to the National Division President immediately after the conclusion of his duties.

ARTICLE IV, SECTION 2, PARAGRAPH 1 BE AMENDED TO READ:

Sec. 2. Excluding the Vice-President at-large, the The office of each Vice President shall be located in the region from which he is elected and as near as practicable in the general locality in which the Vice President resides. The National Division President may assign a Vice President to perform work in another region on a temporary basis. The Vice-President at-large may locate his office at or near his point of residence, or may, with the President's approval, locate his office at headquarters.
